If required by law, the parties agree to complete the transfer through a Federal Firearms Licensee. **As-is sale.** Unless otherwise stated in writing, the firearm is sold as-is, with no warranty expressed or implied. Buyer is encouraged to have the firearm(s) inspected by a competent gunsmith before use. Seller is not responsible for damages arising after transfer.
